- 1. Ensur two exits/two staircases for orderly evacuation of teachers, students and staff in case of any fire incident or emergency.
- 2. Conduct Mock Drill @ twice a year with participation of teachers, students and preferably in presence some of the parents. And take signatures of staff, teachers, parents, student leaders affirming their familiarity with the equipment and its functioning.

# 3. Ensured Electrical Safety by observing the following Precautions:

- a. Installation of Miniature Circuit Breakers (MCBs) in all floors.
- b. No Overloading of power sockets in any Educational Building.
- c. 10 years old wiring to be changed, especially where high power consuming appliances such as Air conditioners, Electrical/Mechanical/Computer labs, Hightech labs, etc., are used.
- d. Grounding/Earthing shall be done.
- e. Lightening conductors may be provided for high-rise buildings exceeding 5 floors.
- f. No High Tension Lines should run inside or in close proximity (< 6 meters) to any Educational institution buildings.
- g. No charging for EV vechiles @ cellars of School/College buildings.

Let the above be tested and certified by any electrical Engineer without regard to any Jurisdiction under employment of Government of Andhra Pradesh once a year.

- 4. As the ensuring safety is a continuous learning process, we will advise from time to time, practical, modern, reliable but not too hard or that require major modifications to your building structure. And you shall undertake to observe these precautions to enhance fire safety.
- 5. Therefore, this building meets the "**reasonable fire safety criteria**" as envisaged in NBC and hence the Renewal Fire NOC is issued.
- 6. As a Policy, no retrospective application of rules shall be made for building as long as they comply with that NOC requirements till the life of the building.
- 7. ### Subject: National Building Code, 2016 - clarification reg.

Sir/Madam,

I am directed to refer to Cabinet Secretariat's OM no. 082/2/1/2020-CA.V(Vol.III) dated 24.01.2025 constituting a Task Force to pursue de-regulation and compliance reduction, to promote ease of doing business and ease of living, towards faster development and job creation. In its interactions with the State Governments, several of them have raised an issue regarding the National Building Code, 2016.

2. The matter has been examined in consultation with the Bureau of Indian Standards and accordingly the following clarifications are issued:-

- The National Building Code is not legally binding. It is a voluntary code for reference. It is not a "code" in the legally binding sense.
- (ii) Being a voluntary document, the National Building Code does not fall under Section 29, read with Section 17, of the Bureau of Indian Standards Act, 2016, and hence non-compliance with the National Building Code does not constitute an offence. In other words, the National Building Code is not "criminalized" and hence, there is no question of "decriminalization".
- (iii) The subject of "Land & Buildings" is listed in List II (State List) in the Constitution (entry 18). Fire Services are also in the State domain, vide Entry 5 of the State List read with the Twelfth Schedule (Entry 7) of the Constitution. Hence, buildings and matters like norms for Floor Area Ratio/Floor Space Index, set back, ground coverage, parking, green area, fire regulation etc. as well as other aspects covered in National Building Code are within the exclusive legislative and executive jurisdiction of the States. The Centre does not have legislative competence over such subjects in respect of State Governments.
- 3. The above clarifications are for information and necessary action.

We send for inspection officers from outside the jurisdiction after selecting them based on their integrity and competence. Don't give them any money. If anyone demands any favour, please inform me on my personal phone number 9441236448. I promise to do justice. You will not be penalised.

Help me to help you to see that entire "NOC" issuing process is carried out in most transparent manner, without any corruption, without any harassment, with genuine desire to help you to solve your genuine difficulties, undue hardship in putting up Some requirements as advised by NBC guidelines which has no statutory backing. It is from your hardships in implementation that we learn and modify requirements based on scientific evidence or experiments for the future buildings as "fire safety" improvement is a continuous process as better technologies come to our aid.

Don't be mislead by any middleman, we have "none". Come and meet me Don't part with Single rupee of your Valuable money. It is my duty to help you get clearances and Certificates from fire department and I Welcome you?
